Today, a global trend of transition to digital mutual settlements between citizens and economic entities has formed and is objectively developing in the world. The largest companies in the world, such as Bitcoin (BTC), Ethereum (ETH), Tether (USDT) and another 9,643 companies with a lower rating have issued digital tokens on existing and positively proven blockchain platforms, and more than half of them participate in transactions on various crypto exchanges with daily turnover from one million to more than 70 billion U.S. dollars.

## Birland's State Currency Today



The Government of Birland has established state banknotes, which have the status of fiat money, and can be circulated in the form of cash. However, in modern conditions, the use of the instrument of mutual settlements in the form of non-cash or cash fiat money requires huge expenditures to create a system of cash flow management, and most importantly, to create a mechanism for withdrawal of fiat resources into international circulation. We believe that the fiat money of the State of Birland should be present in the financial system of the country, used and developed together with digital money, which will ensure a rapid and active process of filling the budget of the country with the necessary external financial resources. State cash and non-cash fiat money together with the State digital financial instruments will complement and support each other, creating comfortable conditions for mutual settlements between the subjects of economic development of Birland.

## Cryptocurrencies as a means of payment

The governments of many countries, including Russia and other countries of both the Eurasian Economic Union and the former Soviet Union – the Commonwealth of Independent States, are systematically introducing digital financial assets – state digital currencies of their countries – as a third type of payment instrument in the domestic and international economy. Digital money is already used in official payments in many countries around the world, in particular, Swiss banks open cryptocurrency accounts (USDT) for their clients along with fiat currency accounts, and the government of Ecuador has accepted Bitcoin for official payments in parallel with payments in US dollars. The number of countries recognizing cryptocurrencies as a means of payment and introducing their own national digital currency is steadily growing.

## Start the procedure of Initial Coin Offering

Following the global trends of transformation of the world financial system, we consider it appropriate to create a state digital currency in Birland. The Ministry of Digital Development will begin the procedure of initial coin offering (ICO) of the digital currency of the state of Birland:

## Filling the treasury of the State of Birland

In order to obtain civil and corporate rights, licenses to use land plots, extract water and minerals, build engineering structures and residential facilities, to purchase government securities, register citizenship and companies in the jurisdiction of Birland, participate in economic and social projects, pay taxes, duties and excise duties, as well as for other purposes of economic and social activities that require the Government's permission, interested parties will have to make payments in the Birla State currency After the ICO and registration of our currency, BGP can be bought by everyone on cryptocurrency exchanges, using their fiat money or USDT, with which the Government of Birland will be able to pay for the purchase of gold in friendly African countries, refining and creating a state gold reserve, which in turn will provide liquidity for BGP. The discount received from gold sellers will constitute the state income and fill the budget with free funds, which the Government can use to finance its own social and economic projects, create internal infrastructure, provide assistance to needy citizens of Birland, cover the costs of developing mineral deposits, water extraction, creating a system of power supply, communications, roads, etc.

## Birland Royal Development Foundation

BRDF fulfills the following tasks:

- BRDF is a tool to popularize the development of the humanitarian state of Birland in the world and a means to attract sponsors, investors and volunteers to fill the foundation with valuable assets.
- BRDF keeps records of the fund's assets, including cash, digital assets, valuable goods, and creates a budget for the development of the State of Birland, distributing incoming values to finance and provide technical support for the fund's programs.
- The basis for filling the BRDF with cash is the income from BGIT's activities in buying discounted gold from friendly African countries. The procedure for generating income is as follows:

BRDF creates and provides funds for social programs to support people living in the territory of the State of Birland, who may later become citizens of Birland. First of all, these are humanitarian aid programs, in which people can receive food, drinking water, clothing, basic necessities, as well as employment with payment of salaries and provision of housing.

## Birland Gold Safekeeping Office



BGSK, as the operator of the Birland Royal Development Foundation, was created to provide the function of safekeeping and accounting of physical gold, silver and diamonds that will be purchased by BGIT to form the valuable assets of the BRDF. BGSK performs the following tasks:

- Organizes the storage and issuance of physical gold to the owners of the Birland Gold Pound digital currency in exchange for BGP.
- Provides valuable property to secure borrowed funds when it is necessary to receive credit or investment resources from banks, companies and private investors for the purpose of financing Birland Projects.
- Receives additional income from storing third-party valuables and from providing ESCRO services to companies and individuals for their own transactions. In the process of developing the authority of BGSK, the Birland treasury will be able to participate in the Projects of our partners and receive income for providing its valuable property to secure obligations under joint contracts and Projects with other partners.

## How to earn Income in the BGP Project – 2 Steps

INITIAL ISSUE: 100BGP = 100USDT = 1gr. Gold 24K

### Step 1

Subscribe to Birlant Golden Pound tokens. To do this, pay for the emission of the required amount of BGP by transferring min. 10,000 USDT to the crypto account of the Birlant Treasury, or by transferring equivalent min. \$10,000 to the current account of the Accredited Financial Operator.

#### Step 2

Register a Birland Gold Pound project participant account on the official Birland community website. After paying for the subscription, BGP will be credited to your personal account balance at a special rate for the initial issue of 1 BGP = 1 USDT = 1 USD. The history of BGP receipts and income accrual will be reflected online 24/7/365 on the participant's balance in the web-cabinet. To receive income, the participant must open a BGP deposit in the project.

How the project works

## ALL PARTICIPANTS' MONEY GOES TO GOLD PRODUCTION

1

The Project Operator, DELTA CAPITAL MANAGEMENT LIMITED, accredited by the Government of Birland, concludes a contract-agent for the purchase of precious metals with each project participant. The Operator uses the money received from the project participants to finance the extraction, purchase, delivery to Dubai and refining of gold into 99.9% bars.

The bulk of the gold received forms the gold reserve of the State of Birland. The physical gold bars after refining are loaded into the vault of a first-class bank in Dubai. The total weight of the bars is 100% equal to the amount of BGP in the emission of the State Digital Currency, based on the calculation of 100,000 BGP = 1,000 grams of gold.

The portion of gold exceeding the volume of the BGP emission is sold on the precious metals market, and the proceeds are used to pay for the costs of the BGP emission, the costs of the project management apparatus, the payment of income to project participants, as well as to finance humanitarian projects and other purposes on behalf of the Government of the State of Birland.

### BIRLAND GOLD ONLINE BANK – OUR NEAR FUTURE

**Birland Gold Online Bank (BGOB)** is an operator of the Birland Royal Development Foundation, a virtual internet bank, officially operating in an offshore jurisdiction of a country where the opening of an online bank is allowed, has a fiat correspondent account with a major world-class bank(s). BGOB is a prototype of the future commercial bank of the state of Birland, but already at a certain stage of development of the Project will perform the following standard functions of the bank:



- Technical platform for mutual settlements between business participants of the State of Birland.
- Issuance of loans in fiat and digital currency to companies registered in the State Register of Legal Entities of the State of Birland to finance projects useful for the development of the State of Birland. Issuance of mortgage loans to citizens of Birland.
- Acceptance of deposits in fiat and digital currency from citizens and companies with payment of income.
